I am pleased to present the IPAA Queensland annual report 2019–20.

As your new President, I would like to acknowledge Immediate Past President, Robert Setter, whose vision and stewardship for re-establishing IPAA in Queensland has been instrumental to the significant progress made.

The past 12 months have been both rewarding and challenging for IPAA Queensland. We continue to make great strides in building a strong foundation for a financially sustainable professional association. Our value proposition continues to grow through delivery of compelling thought leadership events and valuable curated digital content to a broad network of individuals and organisations engaged in public purpose work.

Like other organisations, IPAA Queensland has been challenged by the COVID-19 health pandemic and the necessary shift from in-person to online events and digital content reoriented to support our members and community in the 'new normal'.

During this financial year, IPAA Queensland:

- delivered a highly successful thought leadership program, including eight events that attracted more than 2000 representatives from all levels of government, not-for-profit organisations, professional services firms and universities
- maintained our 27 organisational members, including all Queensland Government Leadership Board departments and four public service offices, and grew our individual members from 85 to 171
- continued our partnerships with KPMG, BDO Brisbane, Queensland University of Technology, University of Queensland and Griffith University as well as established new partnerships with Holding Redlich, McKinsey & Company, QSuper and Brisbane City



Council. These partnerships provide valuable financial and non-financial support, including world class speakers and digital content

- issued 21 editions of IPAA Insights, our fortnightly eNewsletter which reaches members and friends across the state.

In May 2020, the Advisory Council engaged in a strategic planning exercise for 2020 and 2021, facilitated by Griffith University's Dr Ingrid Burkett, Co-Director of the Yunus Centre. As a result, the Advisory Council committed to three strategic priorities:

- grow our membership across the public purpose ecosystem (government, university, community and business sectors) and among young professionals
- provide opportunities for professional development through events and digital content that address good practice and challenge thinking,
- enhance the positive reputation of public purpose effort by bringing together the knowledge and experience from across the public purpose ecosystem to provide a safe and trusted platform for robust discussions and debates for the benefit of our members and communities.

The Advisory Council also affirmed our values:

- inclusiveness: inclusive of and relevant to the rich diversity of ideas, people, organisations and sectors engaged in public purpose work—deliberately inclusive in all that we do
- integrity: honest and ethical behaviour and leadership, providing an independent and safe place for honest and courageous conversations
- service: commitment to service, to positive impacts on members, partners, and friends and on the communities and citizens we serve.

IPAA Queensland is central to powering public purpose work in a rapidly changing world. These extraordinary challenging times remind us of how important the public sector and public purpose workers are to supporting our communities. We are well positioned to promote the ideals of service that drive all of us engaged in public purpose work.

This year IPAA Queensland focused on four strategic priorities—growing the membership, building productive partnerships, enhancing regional engagement, and implementing sound governance arrangements. We also continued to build our value proposition by delivering compelling thought leadership events and curated digital content.

OUR MEMBERS

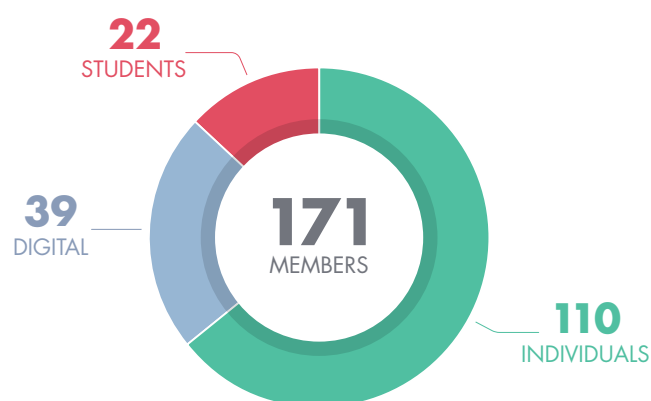
Our 27 organisational members continued their memberships with IPAA Queensland, which comprised of:

- 23 Queensland Government Leadership Board departments
- four public service offices:
 - » Crime and Corruption Commission
 - » Queensland Audit Office
 - » Queensland Treasury Corporation
 - » State Library Queensland.

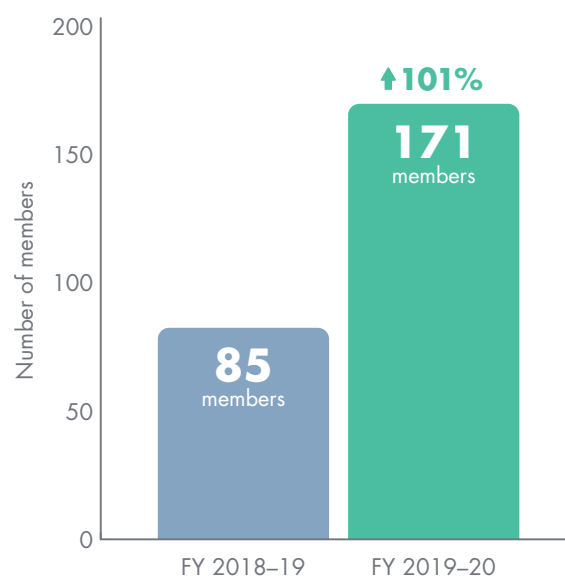
Among the many benefits of organisational membership are complimentary tables at signature events, including the Chief Executives and Young Professionals Breakfast and the Annual Forum.

Individual memberships continued to grow. During 2019–20, IPAA Queensland attracted 171 individual members, up from 85 the previous year for a growth rate of 101%. Benefits of membership include complimentary and/or member rates for events, full access to a growing online library of video content as well as discounts to tertiary courses and events offered by our university partners. IPAA Queensland's digital membership offering provides a cost-effective option for those located outside South East Queensland, enabling them to stay connected with our activities and member-only online content.

OUR EVENTS

IPAA Queensland's strategic program of events delivered in 2019–20 attracted more than 2000 attendees from government agencies, professional services firms, not-for-profit organisations and universities.

These thought leadership forums informed and challenged attendees thinking on topics and issues relevant to public purpose work and (pre COVID-19) provided opportunities for attendees to build their professional connections and extend their networks.

Formal and informal feedback was highly positive with almost all events achieving an excellent Net Promoter Score.

Our signature events—Chief Executives and Young Professionals Breakfast, Annual Forum, and Irene Longman Oration—addressed two themes:

- Future of public purpose work (2019)
- Reframing relationships: Partnerships, community and empowerment in public purpose work (2020).

Beginning in May 2020, IPAA Queensland shifted its events to virtual delivery in response to the COVID-19 health pandemic.

IPAA QUEENSLAND ANNUAL FORUM: **DELIVERING PUBLIC PURPOSE WORK IN THE NEXT ECONOMY**

8 August 2019 | 462 attendees | 5 locations

The IPAA Queensland Annual Forum 2019 was hosted at Brisbane Convention and Exhibition Centre and simultaneously, via live-streaming and on-the-ground facilitators in Cairns, Townsville, Rockhampton and Toowoomba. Participants around the state explored the future of public purpose work with an impressive line-up of keynote speakers, interactive panel sessions and inspiring case studies.

Superbly facilitated by MC Martin Stewart-Weeks, speakers included Thomas King, Annabel Crabb, Professor Anne Tiernan, Jo Sheppard, Michael Eales, Ben Schramm, Lisa Siganto, Adam Fennessy, Karyn Walsh and Robert Setter. Two inspiring case studies illustrating the future of service delivery in action—the Toowoomba Housing Hub and Cairns Safer Streets—were presented by Helen McGrath, Rodney Watton and Simon King, and Nick O'Brien and Riley Myles, respectively.

In 2019, IPAA Queensland launched the Challenger Seminar which brought together multiple experts to examine important topics facing the public purpose sector. STEWARDS **ON THE COUCH**

Several times each year, IPAA Queensland invites a senior public purpose leader to participate in an informal interview 'on the couch' that explores their interests, influences, leadership and views on public purpose work.

These interviews provide attendees with an opportunity to get to know the steward behind the formal role. Interviews are followed with a networking session, enabling attendees to connect with the stewards and other influential leaders and build their professional networks.

This year, in keeping with COVID-19 public health directions around social distancing measures, two of our events were live-streamed to audiences. Registration was complimentary thanks to our partners and both events attracted large numbers and very positive feedback.

Professor Shergold presented a highly compelling and engaging address on how the rise in single-issue parties, identity politics, and declining confidence in governments and elected officials have led to turbulent times for public purpose work and the delivery of public services. He challenged public servants to re-think five fundamental areas of their roles to contribute better to the sustenance of trust in democracy.

Honouring Irene Longman, the first woman elected to the Queensland Parliament in 1929, this annual VIP event is complimentary to members of IPAA Queensland and invited guests.



Professor Peter Shergold AC, Chancellor, Western Sydney University, delivered the 2019 Oration – Democracy under threat: How public services can help maintain faith in democratic governance.

CEO & **YOUNG PROFESSIONALS BREAKFAST**

20 February 2020 | 570 attendees | sponsored by QSuper and KPMG

The annual Chief Executives and Young Professionals Breakfast for 2020 was held at the iconic Brisbane City Hall. Professor Megan Davis, one of the chief architects of the Uluru Statement from the Heart, delivered a powerful, sobering and inspiring keynote address—It's time. Keeping focused on reconciliation. Megan was later joined on stage by Dr Chris Sarra, Director-General, Department of Aboriginal and Torres Strait Islander Partnerships and Kerry O'Brien, esteemed independent journalist, for a frank and passionate panel discussion, facilitated by Lizzie Orley, radio journalist with 98.9 FM.

Young professionals and their chief executives from across local, state and federal governments, business and university sectors were challenged to consider the influence and impact they can make in their own communities and the role all peoples play in the path to reconciliation.



IPAA **AWARDS**

Each year, IPAA National bestows the Award of Fellow to a select group of individuals across Australia who have made an outstanding contribution to the practice or study of public administration and to IPAA. Recipients of these awards are announced at the Annual IPAA National Conference.



In December at our annual Irene Longman Oration, then IPAA Queensland President Robert Setter and former IPAA National President Peter Shergold AC had the privilege of presenting the Award of National Fellow to the Queensland

recipient—James Purtill, Director-General, Department of Natural Resources, Mines and Energy.

James Purtill's distinguished career in public service and public administration spans three decades across both the public and private sectors. A scientist by profession, he is a strong advocate of evidence-based approaches to public policy and for building the capability of technical experts to better translate their analysis and advice for more impactful results. James is a passionate champion for the public sector's role in society and of IPAA's role in advancing the professionalism and value of public purpose work.

OUR **PARTNERS**

IPAA Queensland continues to grow a connected network of individuals and organisations engaged in public purpose work. The number and calibre of organisations interested in partnering with us is a testament to the value that IPAA Queensland brings. Formal partnerships are in place with professional services firms, universities and local government.

REGIONAL **ENGAGEMENT**

IPAA Queensland's commitment to building a strong regional presence across the state to connect individuals and organisations who are engaged in public purpose work in 'place' continued in 2019–20.

Our IPAA Queensland Annual Forum 2019 was live-streamed from the Brisbane Convention and Exhibition Centre to approximately 150 attendees in four regional centres (Cairns, Townsville, Rockhampton and Toowoomba) with facilitators in each to provide attendees with an engaging experience. The program also featured two exciting initiatives from regional centres—the Toowoomba Housing Hub and Cairns Safer Streets. These demonstrated that public service can work differently and that services can be delivered differently for more impactful benefits for clients and communities.

The shift to virtual delivery also provided opportunities to connect with audiences outside South East Queensland. The delivery of two Stewards on the couch events attracted attendees from the regions with 23 per cent of attendees identifying their location as outside of Brisbane.

IPAA Queensland looks forward to continued engagement with regional leaders, universities and councils to better understand local issues, identify future event opportunities and delivery formats that will meet the needs of regional public purpose workers.

OUR **GOVERNANCE**

IPAA Queensland has continued implementation of sound corporate and financial governance arrangements, enabling us to meet our reporting obligations under the *Associations Incorporation Act 1981 (Qld)* and in line with the Australian Accounting Standards.

Implementing our financial governance arrangements and meeting all reporting requirements continues to benefit from the generous support from BDO Brisbane—a leading accountancy and advisory firm with extensive experience in servicing not-for-profit organisations in Queensland. BDO Brisbane provides professional advice, guidance and assistance to IPAA Queensland all on a pro bono basis. We are grateful for their continuing substantial investment in IPAA Queensland.

COMMUNICATIONS AND MARKETING

IPAA Queensland's website, fortnightly eNewsletter IPAA Insights, and YouTube and social media channels continue to perform strongly supporting our three objectives—Build connections, Keep informed, Challenge your thinking. The website's blog and What's On pages feature a curated collection of thought leadership, sector interest and content pieces to keep our audience updated on the latest in best practice.

In addition to the almost 30 blog articles, our website and YouTube channel also feature a growing collection of video content curated from our events. During 2019–20, the number of webpage views was over 31,000 with almost 3500 views to the What's On pages, while our YouTube channel achieved 4340 views and 452 watch hours.

IPAA Insights also continues to engage our audience. We issued 21 editions during 2019–20 with all achieving impressive open (51%) and click through (33%) rates, well above industry standards. Importantly, our website and IPAA Insights regularly feature relevant content from our partners and other organisations with whom we are building connections.

IPAA Queensland's social media channels experienced solid organic growth during the year. With over 96,800 impressions, Twitter has almost 300 followers, a 32% increase. Followers on our LinkedIn channel increased by 51%, and are now over 500. We are pleased to see more and more of the public purpose community connecting with us on LinkedIn and Twitter and expect this progress to continue.

Principal Activities



Notes to the Financial Statements

For the year ended 30 June 2020

Note 1: Summary of Significant Accounting Policies

The financial statements cover IPAA Queensland as an individual entity. The Institute of Public Administration Australia Queensland Incorporated is a not-for-profit (NFP) association incorporated on the 5th November 2018 under *the Associations Incorporation Act 1981* (QLD).

IPAA's registered office and principal place of business is:

The functional and presentation currency of IPAA Queensland is Australian dollars.

(a) Basis of preparation

In the opinion of the Management Committee, IPAA is not a reporting entity, because there are no users dependent on general purpose financial statements. These special purpose financial statements have been prepared to meet the reporting requirements of the *Associations Incorporation Act 1981* (QLD).

These special purpose financial statements have been prepared in accordance with the requirements of the *Associations Incorporation Act 1981* (QLD) and the recognition and measurement aspects of all applicable Australian Accounting Standards ("AASBs") adopted by the Australian Accounting Standards Board ("AASB") and other authoritative pronouncements of the AASB that have a material effect.

The financial statements have been prepared on an accrual basis and are based on historical costs. They do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources.

Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(b) Revenue recognition

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to IPAA and specific performance obligations relating to the types of revenue as noted below have been satisfied.

IPAA derives its revenues through its Membership fees and Events sales. Revenues collected are used to re-invest in services to benefit members and meet the strategic objectives of IPAA.

Membership fees are payable annually in advance. Only those membership fee receipts that are attributable to the current financial year are recognised as revenue.

Ticket sales for Events are refundable in the case the Event does not go ahead. Ticket sales will be recognised as revenue once the Event has been held.

Note 1: Summary of Significant Accounting Policies (continued)

(c) Income tax

IPAA is a registered NFP organisation and is exempt from income tax.

(d) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank.

(e) Trade receivables

Trade receivables are stated at their amortised cost less impairment losses.

(f) Trade and other payables

These amounts represent liabilities for goods and services provided to IPAA prior to the end of the financial year, which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months from the reporting date. They are recognised initially at their fair value and subsequently measured at amortised costs.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

(h) Rounding of amounts

Amounts in the financial statements have been rounded off to the nearest dollar.

(i) Adoption of new accounting standards

The Association has adopted all standards which became effective for the first time at 30 June 2020, the adoption of these standards has not caused any material adjustments to the reported financial position, performance or cash flow of the Association.

(j) New accounting standards for application in future periods

The AASB has issued new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods. The committee has decided against early adoption of these Standards, but does not expect the adoption of these standards to have any impact on the reported position or performance of the Association.




