PRESIDENT'S **MESSAGE**

I am pleased to present the IPAA Queensland annual report for the 2022-23 financial year.

IPAA Queensland's mission of advancing the capability, integrity and professionalism of public administration and promoting pride in service, continues to be exceptionally relevant, perhaps now more than ever.

At a time when trust in government remains a challenge and integrity in public administration receives ever closer scrutiny, our goals of being a voice for the profession and promoting thought leadership and best practice in public administration, are increasingly important. This was highlighted by several high-profile independent reviews over the past 12-18 months, including the Royal Commission into the Robotdebt Scheme at a Commonwealth level, and in Queensland the Review of Culture and Accountability in the Queensland Public Sector (Coaldrake Review).

IPAA Queensland plays an important role in supporting the profession of public service, at all tiers of government in Queensland, to both inform and challenge thinking on such topics. To that end, we were pleased to deliver the first of our new Mastercraft Series on the topic of Royal Commissions and Public Inquiries. Further, we invited Emeritus Professor Peter Coaldrake AO to deliver the Irene Longman Oration. Professor Coaldrake painted an



engaging reflection on the theme of Pride and Purpose in Service, just a few months after he handed down his review of the Queensland public sector.

Further, I was particularly pleased to join my esteemed colleagues, Michelle Lees, Deputy CEO, Services Australia, and Sonia Cooper, CEO, Ipswich City Council, on a discussion panel for our inaugural International Women's Day Stewards on the Couch in March 2023, delivered in partnership with the Australia and New Zealand School of Government (ANZSOG) and moderated by Professor Catherine Althaus from ANZSOG.

We have an important and unique role in tackling some of the timely issues and challenges in public administration and supporting our members to develop best practice responses.

It has been my privilege to serve as President of IPAA Queensland since 1 January 2023, following the retirement from Council of our immediate past President, Ian Stewart AO. Ian was a founding member of the Council since our incorporation in 2018. In December 2022, we presented Ian with our inaugural award of Honorary Life Membership, in recognition of his outstanding and long-term contribution to IPAA Queensland and personal dedication to public purpose work.

This year Council farewelled former Public Sector Commissioner and our founding President, Robert Setter, and welcomed his successor Commissioner David Mackie. I would also like to acknowledge Rob's long-term commitment to IPAA Queensland. Without his passion and hard work leading our re-establishment in 2017-18, we would not exist. In January 2023, we were also excited to welcome Graham Fraine, CEO, Brisbane 2032 Coordination Office to Council and to see our Secretary, Tanya Hornick, take on additional responsibilities as Vice President of IPAA Queensland.



Our partners and sponsors are as committed as ever to supporting us in our mission. They support not only our thought-leadership program, but also our organisational capability. This year, we were assisted by our long-term partner, KPMG, to review our membership model. We thank KPMG for their expertise and look forward to building on the review with enhancements to our model in 2023-24.

Looking ahead, IPAA Queensland seeks to provide even more value to our members by staying at the forefront of the emerging issues and thinking in public administration, and by diversifying our value proposition. The next 12 months and beyond will be an exciting period for IPAA Queensland as we consolidate and reflect on the learnings from our first five years of operation and build on our success.

Finally and most importantly, I thank our members and partners, and everyone who engaged with us at events or online this year. I look forward to seeing you again in 2023-24.

DIRECTOR'S REPORT

The 2022-23 financial year was very successful for IPAA Queensland.

We continued to do what we do best – deliver a program of events that develop thought-leadership in public administration in Queensland. We also revitalised and enhanced this program.

We nudged thinking with our reinvigorated Challenger Series, on two topics both core to and emergent in the practice of public administration. We welcomed international thought-leader, David Snowden, who shared his latest thinking on complexity and citizen engagement. We also asked whether current thinking about crises and resilience should be challenged in the post-COVID world, through a stellar panel of local experts and practitioners.

Further, we strengthened and diversified our program with the launch of our new Mastercraft Series, a masterclass in a core topic or competency in the craft of public administration. The inaugural and very timely topic was also tackled by a leading expert in the field.

Growing engagement with our members and our presence as the professional association trusted by public purpose workers and organisations in Queensland, has been another area in which we excelled. We gained three new valued organisational members and developed several new partnerships with private sector organisations.



Combined, our members and partners are the lifeblood of IPAA Queensland. Membership is held by individuals and organisations who are truly invested in their craft of public administration. We exist to serve those who serve the public – our members. Our partners also play a key role, by providing complementary capabilities and attracting new audiences to our program, they are essential to our continued success.

As we look forward to 2023-24 and beyond, we are keenly focused on 1) ensuring that IPAA Queensland continues to build trust from the sector, and 2) delivering on our mission in new and engaging ways. This year we trialled hybrid events, which allowed both in-room and remote participation for some events. We also invested in delivering more "bite-sized" insights through our LinkedIn channel, which saw us increase our online presence and audience significantly. We also took on topics that straddle both public sector management and public policy, importantly placing us in the wider realm of public administration.

These are a taste of some of the developments members can expect from IPAA Queensland over the next two-tothree years.

I acknowledge our past Presidents, Ian Stewart and Robert Setter, for their leadership and passion for IPAA, and our current President Deidre Mulkerin and Vice President and Secretary Tanya Hornick, for taking up the mantle and leading IPAA Queensland's robust and independent governance.

Finally, on behalf of the IPAA Queensland team, I thank our members for their support and trust, our partners for their collaboration, and the IPAA Queensland Council for their stewardship in 2022-23.


YEAR AT A GLANCE

Organisational members receive a number of benefits, including participation in flagship events such as the



This year IPAA Queensland diversified and strengthened our strategic thought-leadership program, delivering an impressive 11 significant events to over 1,500 public purposes professionals, featuring 28 sector leaders, international experts and thought-leaders.

Our program continued to attract a diverse audience with participants registered from government organisations, professional services firms, not-for-profit organisations, and universities – a reflection of the value offered by our high-calibre, influential program.

We reinvigorated our Challenger Series. This series aims to facilitate discussion on topics and issues that are challenging in their very nature, to spark conversations that can lead to real impact and to be a catalyst for transformation in public purpose work in Queensland. These interactive forums are based on respectful collaboration and are intended to provide a platform to promote ideas and discussion about emerging issues, innovation, and future public service reform.

Demonstrating our strongly held values of inclusiveness, integrity and service, in 2023 we launched what will become the newest addition to our program of annual events – our International Women's Day Stewards on the Couch.

Our CEO and Emerging Leaders Breakfast is a hugely popular event on the public sector calendar in Queensland and this year was no exception. With international keynote speaker, Holly Ransom, we attracted one of our sell-out largest audiences to date for this event, pushing Brisbane's iconic City Hall to capacity.

We also launched the brand-new Mastercraft Seminar Series. These interactive lectures are designed to promote evidence-based and thoughtful practice in public policy and public management, and to develop essential knowledge and skills in the craft of public administration (particularly amongst young professionals and those new to public service). A masterclass in a key capability in the craft of public administration.

Participant feedback from each and every event is exceptionally valuable and helps to shape our annual program. We were pleased to receive excellent feedback this year on all events and our overall program, boosting our net promotor score even higher this year. CITIZEN ENGAGEMENT THROUGH **COMPLEXITY**

RETHINKING CRISES IN A POST-COVID WORLD

Events such as the bushfires, the COVID-19 pandemic, and floods across Australian jurisdictions over the last few years, have required adaptive responses from governments at all levels. At times they have called for unprecedented policy decisions. These have stretched the capacities, resilience and resources of public purpose organisations beyond previous bounds and indeed, that of the communities they serve.

This discussion, led by Dr Anne Tiernan, provoked thoughts and practical insights from our expert panelists: Alistair Dawson (Inspector General Emergency Management), Professor Cheryl Desha (Griffith University) and Collin Sivalingum (Australian Red Cross).

IRENE LONGMAN ORATION

20 October 2022

Our flagship annual lecture, named after the first woman to enter the Parliament of Queensland, Irene Longman, was delivered in 2022 by Emeritus Professor Peter Coaldrake AO.

This timely lecture on the theme of 'pride and purpose in service' honoured Ms Longman's legacy as a public policy innovator, who challenged the status quo and was a true thought-leader of her time.

Professor Coaldrake drew on his long and distinguished career in public leadership and reform, offering learnings and reflections about the important burden, importance and meaning of public service work. Insights that resonated with seasoned leaders as well as new and emerging leaders in the service.

Following the lecture, he was joined by Professor AJ Brown, Griffith University, who opened and led an interactive question and answer session with IPAA Queensland members in attendance.

In collaboration with the Australia and New Zealand School of Government (ANZSOG), and building on the success of our Stewards on the Couch format, we celebrated this important day by showcasing a panel of impressive and innovative public sector leaders and stewards from across three tiers of government.

Our Stewards, Deidre Mulkerin - Director-General, Department of Children, Youth Justice and Multicultural Affairs, & IPAA Queensland President, Sonia Cooper – CEO, Ipswich City Council, and Michelle Lees – Deputy CEO, Services Australia, took to the couch for a candid and thought-provoking discussion about leadership, career journeys, challenges, overcoming barriers, catalysing change, and leading with courage and authenticity. They were joined by Dr Linda Colley, Queensland's first Special Commissioner, Equity and Diversity who set the scene.

NEW MASTERCRAFT SERIES

ROYAL COMMISSIONS PUBLIC INQUIRIES AND REVIEWS

11 May 2023

Royal Commissions, such as the Robodebt Royal Commission, and other forms of public inquiry receive much notoriety and attention across the public and media spheres. But do they all have the potential to spur transformative change? What is their real public policy role? And – why should public servants and the wider public care about them?

This first in our new Mastercraft seminar series saw Dr Scott Prasser, Public Policy Consultant and IPAA Queensland Councillor, deliver a thought-challenging and interactive masterclass on this key area of knowledge in the craft of public administration.





IPAA AWARDS

Each year, IPAA National bestows the Award of National Fellow to a select group of individuals across Australia who have made an outstanding contribution to the practice or study of public administration and to IPAA. Recipients of these awards are announced at the annual IPAA National Conference. The 2022 recipients were announced at the conference by IPAA National President, Professor Renée Leon PSM FIPAA.

The Queensland recipient of the 2022 National Fellow award was Ms Rachel Hunter PSM, Director-General, Department of Premier and Cabinet, and IPAA Queensland Councillor.

The Award recognised Ms Hunter's distinguished service as an accomplished public purpose leader, having led various public sector portfolios over an extensive career where she has driven significant public sector development and reform. She brings an outcomesfocused and values-led leadership style.

She is the first female Director-General of the Department of the Premier and Cabinet in Queensland. She is a member of the Trade and Investment Queensland Board, Building Queensland Board and the National First Secretaries Group. She also serves as the Deputy Chancellor, Griffith University and has chaired the Board of Jobs Queensland providing industry and evidence-based advice on skills needs and workforce planning, and has served as the Chair of Children's Health Queensland.

In 2020, Ms Hunter was awarded a Public Service Medal for outstanding public service to the community of Queensland.

Emeritus Professor Peter Coaldrake AO presented Ms Hunter with her award at the Irene Longman Oration on 20 October 2022.

OUR GOVERNANCE

IPAA Queensland has continued implementation of sound corporate and financial governance arrangements, enabling us to meet our reporting obligations under the Associations Incorporation Act 1981 (Qld) and in line with the Australian Accounting Standards.

Implementing our financial governance arrangements and meeting all reporting requirements continues to benefit from the generous support from BDO Brisbane – a leading accountancy and advisory firm with extensive experience in servicing not-for-profit organisations in Queensland. BDO Brisbane provides in-kind professional advice, guidance and assistance to IPAA Queensland. We are grateful for their continued support for our mission.

OUR EMERGING LEADERS

IPAA Queensland established its Emerging Leaders Working Group in 2021.

The working group supports IPAA Queensland's priority for delivering initiatives that meet the needs of young professionals and emerging leaders engaged in public purpose work. IPAA Queensland recognises that emerging leaders have an important role to play as public service and public purpose work stewards of the future.

The working group provides an important opportunity for emerging leaders and early career professionals from IPAA Queensland member organisations and IPAA individual members to contribute to our vision, direction and activities. Comprised of early career and emerging leaders from the state government, commonwealth government and university sectors, the group provides valuable guidance and advice to ensure that IPAA activities and communications are relevant and engaging to new professionals and up-and-coming leaders. The group led the development of the topic and identification of speakers for the 2023 CEOs and Emerging Leaders Breakfast and played a hands-on role in the delivery of the event. Members of the group have also authored articles for the IPAA Queensland website, enriching and deepening the insights and perspectives shared with the IPAA community.



The group met several times throughout the year and is stewarded and mentored by IPAA Queensland Council Secretary and Vice President Tanya Hornick.

COMMUNICATIONS AND ENGAGEMENT

IPAA Queensland uses four key channels to engage with our members and community.

Website: the IPAA Queensland website features over 110 articles (with 30 published this year) – a curated collection of thought-leadership, sector interest and content pieces to keep our audience updated on the latest in best practice. Our website attracted just under 30,000 views.

Newsletter: *IPAA Insights* also continues to engage our audience. We issued 11 editions during 2022-23, achieving an impressive average open rate (33 per cent) and click through rate (14 per cent), well above industry benchmarks. Importantly, our website and IPAA Insights regularly feature thought-leadership and the latest knowledge from our partners and collaborators. **Social media**: our social media channels achieved solid organic growth during this financial year with nearly 84,000 impressions through our LinkedIn channel which also grew significantly (153 per cent during the reporting period). We are pleased to see more of the public purpose community connecting with us and engaging with our content.

YouTube: our YouTube channel features a growing collection of video content – from event highlights to full webinar recordings and vox pops of our most popular speakers, achieving 1,167 views.



Notes to the Financial Statements

For the year ended 30 June 2023

Note 1: Summary of Significant Accounting Policies

The financial statements cover IPAA Queensland as an individual entity. The Institute of Public Administration Australia Queensland Incorporated is a not-for-profit (NFP) association incorporated on the 5th November 2018 under *the Associations Incorporation Act 1981* (QLD).

IPAA's registered office and principal place of business is:

The financial report was authorised for issue by the Management Committee on 21 November 2023.

The functional and presentation currency of IPAA Queensland is Australian dollars.

(a) Basis of preparation

In the opinion of the Management Committee, IPAA is not a reporting entity, because there are no users dependent on general purpose financial statements. These special purpose financial statements have been prepared to meet the reporting requirements of the *Associations Incorporation Act 1981* (QLD).

These special purpose financial statements have been prepared in accordance with the requirements of the *Associations Incorporation Act 1981* (QLD) and the recognition and measurement aspects of all applicable Australian Accounting Standards ("AASBs") adopted by the Australian Accounting Standards Board ("AASB") and other authoritative pronouncements of the AASB that have a material effect.

The financial statements have been prepared on an accrual basis and are based on historical costs. They do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources.

Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

(b) Revenue recognition

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to IPAA and specific performance obligations relating to the types of revenue as noted below have been satisfied.

IPAA derives its revenues through its Membership fees and Events sales. Revenues collected are used to re-invest in services to benefit members and meet the strategic objectives of IPAA.

Membership fees are payable annually in advance. Only those membership fee receipts that are attributable to the current financial year are recognised as revenue.

Ticket sales for Events are refundable in the case the Event does not go ahead. Ticket sales will be recognised as revenue once the Event has been held.

Note 1: Summary of Significant Accounting Policies (continued)

(c) Income tax

IPAA is a registered NFP organisation and is exempt from income tax.

(d) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank.

(e) Trade receivables

Trade receivables are stated at their amortised cost less impairment losses.

(f) Trade and other payables

These amounts represent liabilities for goods and services provided to IPAA prior to the end of the financial year, which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months from the reporting date. They are recognised initially at their fair value and subsequently measured at amortised costs.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flows.

(h) Rounding of amounts

Amounts in the financial statements have been rounded off to the nearest dollar.

(i) Adoption of new accounting standards

The Association has adopted all standards which became effective for the first time at 30 June 2023, the adoption of these standards has not caused any material adjustments to the reported financial position, performance or cash flow of the Association.

(j) New accounting standards for application in future periods

The AASB has issued new and amended Accounting Standards and Interpretations that have mandatory application dates for future reporting periods. The committee has decided against early adoption of these Standards, but does not expect the adoption of these standards to have any impact on the reported position or performance of the Association.

Report on the Audit of the Financial Report

Opinion

Our opinion on the financial report does not cover the other information and accordingly we do not express any form of assurance conclusion thereon.
